Department/Govt. approved organization for similar type of works completed within last 4 years of value not less than 50% of the estimated value in a single work.

3. Tender paper will be issued to eligible contractors only. Decision of the C.E.O., Board of

Auqaf, West Bengal regarding issue of tender paper is final.

4. Tender paper may be submitted in the Tender Box kept in this office within stipulated date and time. Tender paper received after stipulated time will not be entertained. Tender will be opened at the stipulated date and time and intending Tenderers may remain present at the time of opening of tender.
